



### REQUEST FORM FOR I-20 TRAVEL ENDORSEMENT

The purpose of this form is to determine eligibility for travel endorsement and to reduce difficulties that may be encountered upon re-entry into the United States.

- **Your Form I-20 will be endorsed for reentry into the U.S.** if you are eligible and intend to continue your studies at Essex County College upon your return from travel. If you have completed your program of study and you have been authorized by USCIS for practical training employment, it will also be endorsed for travel.
- **Your Form I-20 will not be endorsed for travel:** if you have completed your program of study (even if you haven't yet attended graduation) or if you do not intend to study at Essex county College upon your return. Your Form I-20 will not be endorsed for travel if you have completed your program of study, but have not yet obtained practical training employment authorization.
