Instructions on Obtaining a 2019 Verification of Non-Tax Filing Letter

Federal regulations require that each individual who indicates that they did not file a 2019 US Income Tax Return must submit proof of non-tax filing status.

You must submit an IRS Verification of Non-Filing Letter, along with a signed Statement of Non-Tax Filing (form (reverse side of this form), if you are:

- An independent student
- Dependent student
- Student's spouse

There are two options for obtaining from the IRS a Verification of Non-Tax Filing Letter

<p><u>Obtain a PDF version of the 2019 Verification of Non-Filing Letter for the IRS website</u> https://www.irs.gov/individuals/get-transcript</p> <p>After completing the registration process (or logging in if a returning user), select "Higher Education/Student Aid" as the reason you need a 2019 Verification of Non-Filing Letter, and then click 2019 under "Non-Filing letter" to view the document. Print and/or save the document and submit a copy to the Office of Financial Aid, with your name and ECC Student ID # printed at the top of the page.</p> <p>For security purposes, first-time users will need the following to register:</p> <ul style="list-style-type: none">• Your social security number, date of birth, filing status, and mailing address;• Access to your email account• A mobile phone with your name on the account• A personal account # from credit card, mortgage, home equity loan, home equity line of credit, or car loan. Individuals who do not have one of these accounts must use the option below.	<p><u>Complete the Request for Transcript of Tax Return (Form 4506-T).</u></p> <ul style="list-style-type: none">• Complete Items 1-4,• Check the box for "Verification of Non-filing" (Item 7),• Enter the year "12/31/2019" in Item 9• Sign & date at the bottom. <p>Mail or fax the form to the address or number on Page 2. Do not enter Essex County College as a third party in Item 5; the IRS Letter must be mailed directly to the individual requestor.</p>

After completing 1 or 2, you will receive the verification of non-filing letter from the IRS by mail. (Should you have difficulty obtaining this letter, please complete the form on the reverse side)

After you receive your Verification of Non-Filing Letter from the IRS:

- Check to make sure the document you received is correct.
- Keep a copy for your own records.
- Write the student's name and ECC ID # on the top of IRS letter. (Please note: There is no identifiable information on this form. Unless you write your name and ID# at the top we will not know who it belongs to.)
- Submit the Verification of Non-Filing Letter to the Financial Aid Office. Once all documents are received by this office, it will take additional processing time to review and, if necessary, to update the information. Your student aid eligibility cannot be finalized until all required documents are received and processed.
