West Essex Campus – New Parking Structure and Integrated Campus Plan

The new parking structure and an integrated campus plan at the West Essex Campus (WEC) align with the current construction of the new academic building. The new undertakings are a continuation of the College's efforts to provide quality service to its communities and the County.

The redesign includes a multilevel parking deck for approximately 350 vehicles and an elevated pedestrian bridge. It also includes an overall campus design plan with a new integrated synthetic soccer field with sports and landscape lighting, spectator seating, restrooms, and utility building/storage, pedestrian circulation, bus and sports team vehicle parking, pedestrian connections to the sports fields, and the entrance to the new academic building and its infrastructure. The joint venture collaborates with the County, the College, and Comito Associates Architecture to provide general architectural, engineering, environmental, geotechnical, and professional services.

These capital investments in the West Essex Campus focus on:


- Increasing the College's contributions to our serving areas' economic, social, and cultural development.
- Maximizing the response to the educational needs of our sponsoring areas.
- Supporting future student enrollment and the West Caldwell Township community events through an enhanced parking deck.
- Collaborating with the Essex County West Caldwell Tech High School officials on using the soccer field to promote sports activities within the high school and college campus communities.







RECOMMENDATION: It is recommended that the Board of Trustees authorize the administration to request that funds in the amount of \$6,000,000, from several Chapter XII Bond Ordinances allocated to various projects that are no longer viable for the institution, be reallocated for a new parking structure and Integrated Campus Plan for the West Essex Campus project, and other ECC capital expenditure improvement projects.

BACKGROUND AND RATIONALE:

The College's West Essex campus needs a new parking structure due to requirements of the township of West Caldwell, the expected growth in our student population, and future plans for program offerings. Additionally, to accommodate other features of the new academic facility, an Integrated Campus Plan is needed for a new integrated synthetic soccer/lacrosse/track sports field with sports and landscape lighting, spectator seating, restrooms, an elevated connecting bridge/walkway connecting pedestrian circulation to bus and sports team vehicle parking, sports fields and the entrance to the academic building and its infrastructure.

FISCAL NOTES: The amount to be reassigned is \$6,000,000 and will be reallocated from designated Chapter XII Bond Ordinances and other projects that are no longer viable for the institution.

RESOLUTION: The Board of Trustees authorizes the administration to request that funds in the amount of \$6,000,000, from several Chapter XII Bond Ordinances allocated to various projects that are no longer viable for the institution, be reallocated for a new parking structure and Integrated Campus Plan for the West Essex Campus project, and other ECC capital expenditure improvement projects.

RECOMMENDATION: It is recommended that the Board of Trustees of Essex County College accept additional funding from the County of Essex in the amount of eight million dollars (\$8,000,000) for capital outlay dedicated to construction of a new parking deck at the West Essex Campus and other College pragmatic projects.

BACKGROUND AND RATIONALE: The county of Essex, led by the County Executive, offered to the College additional money to dedicate to the construction of a new parking deck at the West Essex Campus, including but not limited to other College pragmatic projects.

FISCAL NOTES: The funding will increase the College's capital budget.

NOW THEFORE, BE IT RESOLVED by the Essex County College Board of Trustees as follows:

- 1. The Board of Trustees of Essex County College accepts additional funding from the County of Essex in the amount of eight million dollars (\$8,000,000) in Fiscal Year 2022, exclusive of authorized Chapter 12 funds, for capital outlay dedicated to construction of a new parking deck at the West Essex Campus and other College pragmatic projects.
- 2. The President of Essex County College shall ensure that a copy of the statement of the said amount of money estimated to be necessary for all capital outlay expenses for the fiscal year ending 2022 be delivered to each member of the board of school estimate as soon as practicable;
- 3. The President of Essex County College shall ensure that appropriate notice of a public hearing by the Essex County College Board of School Estimate be provided;
- 4. A copy of the itemized statement be on file and open to examination of the public: 1) on the Essex County College website at www.essex.edu; and 2) at the Office of Administration and Finance, Essex County College, Room 6116, 303 University Avenue, Newark, NJ 07102.
