# General:

I am pleased to announce that Covid-19 cases have significantly dropped on our campus.

# Academics / Enrollment:

- ✤ We are fully engaged in implementing Winter/Spring 2023 Recruitment and Enrollment initiatives.
- A review of our Academic Programs is underway with a view to upgrading program offerings based on market demand and student needs.
- ◆ The review includes agreements that streamline the transfer process to 4-year institutions.
- Our college-wide initiatives to improve enrollment, retention, and graduation are paying off.

Table (1) below shows the total number of students and total credit hours for the last 3 Fall semesters.

Our Fall-to-Fall Retention rate for this semester is **averaging 60%**, indicating a significant increase from the semesters prior to Fall 2021.

Our Graduation rate has increased to an all-time high i.e. Fall 17 Cohort = **11.1%**; Fall 18 = **14.4%** and Fall 19 = **16.7%**.

## College Events/ Important Meetings:

- October 19, 2022 Dr. Falecia Williams, Middle States Evaluation Team Leader assigned to ECC, completed her preliminary site visit to our college. Dr. Williams also serves as the President of Prince Georges Community College in Maryland.
- October 25, 2022 Dr. Boakye held a successful meeting with our Union Leaders to discuss the State of the College and strategies to expand and enhance the student experience.
- November 2, 2022 the Business Division held its Annual Business Week events which attracted several 4-year institutions, publishers, students, and alumni.
- November 3, 2022 Dr. Boakye was joined by Dean M. Seddiki, Dean K. Kirkland, Mr. J. Shapiro, Mr. P. Jalloh, Mr. M. Doughtie, and Mr. A. Cromartie on a visit to our athletes' residence. The students appreciated the visit and we made note of areas for improvement.

- November 3, 2022 Dr. Boakye and the administrative leaders welcomed our new employees to ECC using the Meet and Greet session to share our passion for the mission, vision, and values of ECC.
- November 3, 2022 Our Middle States Steering Committee continued its series of Town Hall meetings to update the College community on our reaccreditation process and provide opportunities for questions and feedback.
- November 3, 2022 Dr. Boakye participated in the Pan Africana Exhibition organized by Dr. Akil Khalfani, Director of the Africana Institute. The event attracted several community members to the College.
- November 5, 2022 Dr. Boakye participated in the Board of Trustees retreat with Mr. J. Runfeldt.
  The event provided an opportunity to discuss progress on our reaccreditation, the President and BOT Annual Evaluations, and ensuring that the needs of students continue to be our primary objective.
- November 10, 2022 Dr. Boakye attended the ECC Chapter of Phi Theta Kappa (PTK) Summer / Fall 2022 Induction Ceremony. In his address, Dr. Boakye encouraged students to value their experiences at ECC and assured all attendees of the College's commitment to student success. In all, 154 students were inducted into the Honor Society.
- November 12, 2022 Dr. Boakye participated in the Financial Freedom Literacy Conference organized by Rev. Dr. DeForest Soares and hosted by Dr. Lamont Repollet - President of Kean University. Dr. Boakye used the platform to highlight ECC as a *college that promotes debt free education.*

## **Finances**

Our FY (Fiscal Year) 22 Audit is in progress. The Enrollment Audit portion is now complete. The appropriate report was submitted to the State's Treasury Department in October 2022.
