Call to Order/Roll Call:

Chair Trustee Bolden called the meeting to order at 4:32PM. A quorum was achieved with 9 trustees in attendance.

Counsel Townes announced the agenda item numbers were incorrect and should be noted as 7-3.1 and 7-3.2 instead of 7-3.4 and 7-3.6. He also advised that a separate vote had be taken for 7-3.2 for minor amendments.

Trustee Cruz said that the Policy and Governance Committee met last week and presented action 7-3.1 for approval:

Community Relations Committee Report:

Trustee Wright reported that the Community Relations Committee did not meet this month. Therefore, there was no report.

Alumni Association Report:

The Alumni Association report submitted to the Board of Trustees was read into the record of the meeting by Ms. Stephenie Carter. The report is attached at Appendix A.

Student Government Association Report:

Ms. Yadhira Rosales submitted and Mr. Zachary Miller read the Student Government Association report which is attached at Appendix B.

Ms. Yadhira Rosales reiterated what Zachary read and said that they are doing a great job.

Trustee Bolden said that she was excited by what was presented. She asked if they needed to ask anything from the Trustees that could possibly help them. Zachary replied that they do not need anything as of yet and they are currently gathering information about the student. Trustee Bolden said that they are here to help the SGA in their efforts.

Faculty Association Report:

Professor Alexandre spoke about being the new president of the Faculty Association:

- On behalf of the faculty association, he welcomed everyone for the new academic year of 2022-23.
- He will be taking over after Professor Michael Frank, who did a great job for the past decades. That will be very large shoes to fill. He thanked him for the great job that he did. What he prepared for them is what they are going to continue to work on. He is ready to mentor him into the new world and he is very happy about that.
- Professor Alexandre said that he is not new to ECC and has been around for the past 20 years. He started as a student and graduated in 2003. He came back in 2011 as an adjunct faculty. In 2014, he was put on the tenure track and 4 years later he became a full-time tenured faculty.
- This position is very important to him to represent the faculty because ECC means a lot to him. When he came to this country in 2020 as an immigrant from Haiti, he did not come with anything. All he has now has come from being at ECC.
- The faculty wanted to have a new executive board not because they had a problem with the previous board, but because they felt it was time for a change. When they asked him to run he was hesitant, but he accepted the invitation. He wants to work with the administration so that they can continue to move this college forward.
- The College has been like a family. When he was here he was happy to see that they could interact and bond with the professors and the president.

- Now the times are different and the faculty sees that the college is heading in a new direction. They are very happy to see that professors are being promoted because they had not seen promotions in a long time.
- The faculty is sad to see some of the professors leaving such as Dr. Ned Wilson, who was the president of this association. The faulty thanks Dr. Wilson for his service and they will try hard to continue the work that you had started over 50 years ago.
- Most members on the executive board are new with the exception of one faulty member. One of the focuses of the new executive board is to encourage and promote the faculty members and their work. They are doing great things not only at the college but in the community and their fields. Academic affairs just came up with an initiative to put the faculty's pictures and biographies on the ECC website so that people can see the quality of the faculty at the College. They applaud Dr. Williams for his great initiative to put faculty members on the website. The majority of them are pretty happy with the direction of the college because they were a little worried for the past year. But they are a little concerned as well about inflation. Inflation is putting them back where their salary is not keeping up with their expenses.
- Faculty retirees are talking about their fear of being cut out when they leave the College
 after passing their keys. The faculty association is looking at ways of connecting with them
 to keep them in touch with the college.
- He thanked everyone.

Trustee Bolden thanked him for his passionate presentation and congratulated him on being the new representative of the faculty association. She said that he can reach out to the Board at some point and they could have conversations. She was glad that he is happy with the direction they are going in and they will try to continue to maintain that.

Trustee Cruz congratulated him and welcomed him aboard. She was glad that there is an ECC alumnus in the association. Trustee Bolden agreed.

President's Report:

Dr. Augustine A. Boakye read and submitted the President's report. It is attached as Appendix C. He talked about the following points:

- He welcomed faculty, staff and students.
- Fall registration was not over.
- College Factual was rated ECC as number one in the country for our allied health programs.
 ECC's certificate programs do very well.
- ECC was rated as one of top 5% offering a finance program. He thanked everyone for their support and contributions.
- He said that the school is doing well with the graduation rate because it has increased.
- Our NASA community college event went well. It lasted for four days and included different colleges.
- The College intends to renovate the cafeteria with the current vendor.
- The WEC is coming along well.
- As far as community relations, ECC welcomed the newest president of NJIT. ECC and NJIT will
 partner together on future projects. The new president of Montclair State University had his
 investiture and ECC provide support.
- He thanked all the retirees. He congratulated the employees on their promotions.
- He announced the events that are coming up in the fall.
- The Middle States preliminary visit will be on October 18th to 19th.

He thanked everyone who is part of the college.

Trustee Bolden congratulated the college for its College Factual first place ranking. She said she will try to support upcoming events.
