### Call to Order/Roll Call:

## MEETING WITH SGA EXECUTIVE BOARD & SENATORS

On January 14th, 2023, all SGA officers held a zoom meeting to discuss plans for the semester. We addressed new goals for the academic committee, including plans to streamline the process of class sections being canceled abruptly. We then discussed plans for the disbursement of the \$6,000 given to us as club money and reached a fair conclusion. Under the new plan \$2,000 will be given equally to all active clubs as a discretionary fund, \$3,250 will be set aside for specific items through the proposal process, and \$750 will be kept for an SGA budget/emergency fund.

## ICC MEETING WITH OTHER CLUBS & ASSOCIATIONS

On January 19th, 2023, the SGA had an ICC meeting with other clubs in preparation for the club fair and each club's plans for the semester. The Film Club will start working and filming with outside institutions like NJIT and RU. Music Club & LGBTQ+ Club planned to hold competitions and work with local community centers on various activities. All ICC attendees were also invited to the next student forum in order to provide a more diverse slate of topics to discuss.

## SGA ACCOMPLISHMENTS FOR THE MONTH OF JANUARY & DECEMBER

We appointed a new senator-at-large, Kate Bontia. We interviewed and appointed a student that is interested in being an assistant treasurer in replacement of our graduating treasurer, Paula Moore. We now have a finance committee that consists of the Senator of Non-Academic Affairs, Rayuanna Benjamin, and assistant treasurer, Metishia Monroe. The new senator and assistant treasurer have already started working on their committee assignments and supporting SGA initiatives. SGA also participated in the Middle States town hall from December.

### SGA HOLIDAY SHOW

At the end of the Fall semester we hosted a holiday show for the school. We invited 7 clubs to participate with around 60 club members from all clubs together. It was a massive success with around 100 people attending. The Music club performed multiple holiday songs, the Step and Dance club danced to a variety of songs, the Cheer team gave a wonderful taste of ECC pride, the African/Black Student Association informed us about Kwanzaa, the Essex TaeKwonDo club showed off their skills and a thrilling rendition of a prop knife fight, Gaming Anime club hosted a jeopardy match based on video games and anime, and Phi Theta Kappa provided volunteers as ushers. ## **General:**

We continue to monitor Covid-19 cases on campus and remain vigilant following CDC guidelines and local regulations.

## Academics/Enrollment/Student Support:

- The Spring 2023 semester started on January 9, and so far, instructions and learning activities are moving smoothly.
- The Office of Student Affairs, SGA and the Alumni continued to support students and their families during the Christmas break. Through their Angel Tree Program, the Alumni Association collected holiday gifts which were donated to children in Apostles' House Newark, and the Turning Point Community Services Irvington.
- Following data gleaned from its Student Needs Assessment surveys, the Office of Student Cares is providing targeted support to students using college and county services for food, SNAP, mental health, transportation and disability services.

Congratulations to Mr. Chinanu Edward Igbokwe on his full-time job in a NASA Aerospace Engineering Company and to Ms. Perez Yelitza, NCAS -2019 Alumnus, who also got a job at a NASA partnering company.

## The President's December/January Engagements have included:

- Welcoming the ABET accreditation team to ECC for an onsite visit.
- Championing the Annual Employee Recognition Event where 46 employees were honored and received certificates of appreciation for meeting 5, 10, 15, 20, 25, 30, 35, 40, 45 and 50 years of service. Professor Allen J. Singleton and Dr. Ned Wilson were recognized with Professor Emeritus status.
- Financially supporting over a hundred ECC students with Presidential scholarships to overcome their outstanding bills and create a path for them to register for the Spring 2023 semester.
- Participated in the LPN Pinning Ceremony on January 20, 2023.

## Finances:

Our FY (Fiscal Year) 22 Audit is underway. The College continues to work on initiatives to bring funds to the College through grants and scholarships.

## **Projects:**

Capital projects at the College are progressing well and future projects are under review and discussion.

The West Essex campus construction project is on schedule to be completed in June 2023. Both the construction of the classroom block and the parking deck are progressing well.

The fencing of the Student's Deck – Newark campus was successfully completed on January 19, 2023.

## **Community Relations:**

I continue to participate in all NJ Presidents Council Meetings to advocate for funds and contribute to the success of our state colleges/universities.
