#### Call to Order/Roll Call

## **Activity Report:**

Recruitment Table (May 27 – May 30, 2024):

- The SGA hosted an informational recruitment table from the week of May 27 to May 30, 2024, reaching out to students for participation in student governance. ## **Faculty Update/ Activities**

## **Update from the Office of Student Development**

- In May, during Mental Health Awareness Month, the faculty counselors from the Office of Student Development—Jennifer Chapman, Ada Torres, Cassandra Johnson, and Dr. Kathlyn Ann Battle—organized and engaged in various discussions and activities aimed at reducing the stigma associated with mental health. These initiatives were open to students, staff, faculty, and administrators alike. This May marked the inaugural Mental Health Awareness Month Symposium and the launch of our mental health campaign. Professor Jennifer Chapman is now offering virtual Talk and Text therapy sessions, as well as in-person Expressive therapy, to students from both campuses.
- As part of our ongoing campaign, we conduct periodic Mental Health First Aid Workshops led by Professor Jennifer Chapman and Dr. Kathlyn Ann Battle. Over the past year, we have organized three workshops catering to various student populations. As Nationally Certified Mental Health First Aid Instructors, these workshops enable us to train students to identify mental health issues in themselves and others, provide initial assistance, and assess the need for further help or referrals to additional services. By the end of the comprehensive 8-hour course, students' awareness, sensitivity, and knowledge about mental health are significantly enhanced, and they receive certification as Mental Health First Aiders. Many of the students trained through these workshops have graduated from ESSEX with degrees in Nursing and Human and Social Services, now equipped with certification valid for the next three years.
- Professor Ada Torres and Professor Cassandra Johnson are Nationally Certified Suicide
  Prevention (QPR-Question, Persuade, Refer) trainers and they also train students throughout the
  year to recognize the signs and symptoms in others and themselves to reduce the attempts and
  completion of suicide.
- Professor Victor Stolberg Update
  - Attended several meetings this month, including those for Academic Standards Committee (ASC), Academic Policies Advisory Committee (APAC), the Faculty Development Committee (FDC), the Diversity, Equity and Inclusion (DEI) Committee, the Faculty Contract Negotiation Team, and the Board of Trustees; as well as some in the community, such as for the Board of the Friends of the Newark Public Library
  - 2. Volunteered at the Bessie Green Community "The Red Door" Food Bank.
  - 3. Completed inclusiveness-related SafeColleges trainings such as "The Influence of Unconscious Bias in Decision Making," and "Accommodating People with Disabilities," as well as Medscape continuing education, mainly on various

- disabilities, like "Alzheimer's Disease," "Dementia," "Depression," "Drug Use," "Multiple Sclerosis," "Postpartum Depression," "Schizophrenia," and "Tuberculosis."
- 4. Attended the Retirement Celebration for Cheryl Newton-Banks.

## **Radiography Program**

Essex County College Radiography Program is ranked #3 in New Jersey for 2023 with an American Registry of Radiologic Technologists (ARRT) Mean score of 87.0 (Program #1 has mean score of 88.5 and #2 is 87.6) in The NJDEP Radiologic Technology Board of Examiners' annual comparison of New Jersey and ARRT examination results of the 15 programs reporting ARRT scores.

Our program surpassed the #1 ranked program in the sections of Radiation Protection (8.9 vs. 8.8), Image Acquisition and Evaluation (9.2 vs. 8.9), Equipment Operation and QA (9.1 vs. 8.9), Thorax and Abdomen Procedures (8.8 vs. 8.6) and scored the same (8.7) in Head, Spine, and Pelvis Procedures.

ECCFA would like to thank Professor Darlyn J Warner, MSRS, RT (R)(M), Radiography Program Coordinator for her outstanding work with the radiology program.

## General:

On behalf of our graduates, I thank the College community for celebrating the accomplishments of our students during the May 23<sup>rd</sup> Commencement ceremony. Our graduates are living proof that Essex County College continues to live our mission to serve the diverse needs of students through comprehensive educational programs, training and continuing education. The almost 1,200 graudates, Class of 2024, will never forget ECC.

## Academics / Enrollment / Student Support:

- The launch of RedShelf (Textbook Vendor) for Summer I course offerings was successful. We are
  reviewing student and faculty participation data to increase consistency in preparation for Summer
  II and the Fall semesters.
- Our Academic Affairs team is making progress with the following institutions on Articulation Agreements:
  - NJIT: Regarding ECC Associate Degrees in Engineering, Computing and Mathematics,
  - Rutgers University Newark: Regarding ECC AS degree in Psychology.
  - Saint Elizabeth University: A pathway for ECC AS degree graduates in General Science to transfer to the Nursing program at St Elizabeth.
- Our Community, Continuing Education and Workforce Development office is in the final stages of
  implementing the PACE grant's Fiber Optics project. We are thrilled to work with our community
  partners to bring this to Essex County.

## The President's May/June 2024 Engagements:

- May 23rd: Participated in the Nancy Cantor Scholarship fundraiser.
- May 24<sup>th</sup>: Participated in the NJCCC Presidents Lampitt 2.0 discussion to continue to provide a seamless transition from public associate to public baccalaureate degree programs in NJ.
- May 29th: Met with ECC union leaders representing our college's collective bargaining units. I thanked them for their dedication to the ideals of our institution and we each committed to work hard to move our institution forward for the benefit of our students and the community.
- May 31<sup>st</sup>: Participated in the NJ Presidents meeting.
- June 11 13: Attended the New Jersey Community Colleges Opportunity Summit in Atlantic City focusing on Pathways and Promising Practices for Holistic Student Supports. I was accompanied by Deans Williams, Kirkland, Vieira, Mr. Bundy and a few other staff.

#### Finances:

- Both the Office of the Secretary of States (OSHE) and the New Jersey Office of the State Comptroller (NJOSC) have recently been tracking the Higher Ed institutions including ECC to ensure that each institution is financially sound and maintaining a reasonable reserves against future financial risk.

• We are working with KONE Elevators on a preventive maintenance contract for the West Essex Parking Deck and OTIS Elevators for the Academic Building.

## **Community Relations:**

• Our Summer Youth Program is scheduled for July 8th - August 16th for grades 1-8 / ages 6-13.
