Public Comments

Lev Zilbermintz submitted his report electronically. It reads as follows:

Greetings,

Another year is ending. So, without further ado, here are my public comments.

First, the college cafeteria. There is much that could be improved. To begin with, in the afternoon I only see two employees working in the Cafeteria. One acts as the cashier/pizza man/sweeper etc., while the other

does the sandwiches and other food. This is absurd, especially when there are many customers in the cafeteria. Why cannot you have an additional one or two employees helping out when necessary?

The Student Government should have a Cafeteria Committee meeting at least monthly with the Cafeteria management and students. I think that the price of fruits is too high. Also, why are there no miniature milk cartons in the freezers? If you want to buy cereal with milk, then you have an inconvenience. You have to pour milk from a gallon. No other school has this sort of thing.

Second, and this may surprise you, there is a time capsule buried at Essex County College. It was buried in 1976, when this building was being completed. That capsule is supposed to be taken out in 2026, two decades after it was buried. From my research, it appears that the capsule is buried where the first part of the third floor is now. Mamie Bridgeforth would definitely know where it is. I remember her saying that the time capsule was buried and then it was built over. The Star Ledger from mid-September 1976 should have the details. Anyone who worked here in 1976 - Ned Wilson, Arthur Taylor, Patricia Richardson, et al - would recall the time capsule. Ground penetrating radar would easily locate the capsule. I think it is a big safe from the 1970s, full of old documents, yearbooks and other stuff.

You want to bury a new time capsule in 2026?

E-BOARD MEETING

An emergency Executive Board meeting took place on December 16, 2024. Overseen by Dean Bello, the meeting addressed internal group matters, concluding on a positive note with a commitment to improvement in the upcoming semester. A part of this discussion was mentoring our General Membership to take on Leadership roles as some of the Executive Board members will be graduating in June.

ICC MEETING/FORUMS

We conducted an ICC meeting with the other clubs on the 18th of November 2024. A total of 9 clubs attended the meeting. The Student Forum has been postponed due to finals this month. In the Spring semester, the SGA will implement new changes, including updated guidelines for Executive roles and the introduction of additional Executive and Senator roles to better distribute responsibilities.

COMMITTEE MEETINGS/FACULTY GOVERNANCE

As a part of the SGA Constitution, the student body is represented through SGA representation on Faculty Governance and other College Committees. Our Executive Team has reported the following as a result of attending the below meetings.

ASC (Academic Standards Committee)- Our FYE (first year experience) was intended to help students register, understand teaching systems, and adapt to college life, but many still face challenge. Is the course effective, or should FYE be restricted by department- should they be promoted? These concerns will be reviewed at the next meeting.

FDC (Faculty Development Committee)- Working on Reducing the time spent on preparatory math classes. Faculty development course assignment, curriculum restricting, articulation agreement, resources, counseling and advisement. Awaiting Math 095 data, relevant to 10% of STEM students. Details will be discussed in the next meeting.

DEI (Diversity, Equity and Inclusion) College Wide Committee- Two members of SGA attended their first DEI College Wide Committee meeting. They were given the DEI plan and brought up to speed on how the committee functions.

HOLIDAY/CLUB EVENTS

The Holiday Show, held on December 5th in Smith Hall, was a resounding success, featuring outstanding performances. Skits, songs, and showcases were presented by the Music Club and other participating groups. We eagerly look forward to even grander celebrations next year!

SGA also assisted in the Holiday Tree Lighting, held on December 4 by distributing treats to the student body.

Our Fall 2024 term ends on December 21st. We served 7,026 degree-seeking students enrolled in 71,451 credit hours this semester, outperforming Fall 2023 in both categories.

Academics / Enrollment / Student Support:

- Our Faculty are providing end of semester support and students are working hard for the final exams.
- This year's Winter Intersession will run from December 26th January 9th.
- We will have a small staff in the Center for Technology (CFT) to support our Winter Intersession students and handle prospective student inquiries normally handled in the Welcome Center.
- The Business Division Faculty completed and submitted their ACBSP reaccreditation Self-Study.

- Starting on December 12th, a mental health therapist will come to the Main Campus to support students. The therapist will be housed in the Student Development and Counseling Center on the 4th floor.

Projects:

- Final modification of the CFT construction documents is underway.

Community Relations:

- We raised \$1,300 on Giving Tuesday this year. We appreciate everyone's support.
