The following information must be kept and reported for each employee: the name, the actual hourly rate of wages paid, and the actual daily, overtime and weekly hours worked.

4 Services #8207 and give details?

Answer: This is the 6 yarder designated for food disposed by the cafeteria and must be picked up daily before 7am. The container located at the Lot A.

All service listed on the Bid Price Sheets are scheduled as "will call" with the exception of one(1) 6 yard container located at the Newark Campus-Loading Dock. That is listed as a "Daily Pick-up". Is daily pick up consider 7 days a week or 6 days?

Bid Price Pick-up". Is daily pick up consider 7 days a week or 6 of Sheet #8207 Also, is that the only container that is not "will call"?

Answer: 6 days. The cafeteria is closed on Sunday and will not generate food waste.
